Residential Zoning	I submit that the proposed District Plan does not provide sufficient additional residentially zoned land within close proximity to the Washdyke. Rezoning more land within this vicinity would provide more suitable land for affordable houses to be built to meet the demand for this level of housing in Timaru.	Rezone the land on the true right of Papakha Stream within records of title CB22F/884 and CB22F/885 to General Residential. Should this not be supported, then as a fallback position I submit that this area of land become a Future Development Area for residential development as a priority area for a Development Area Plan within 2 years.
Future Development Areas	I am neutral on the proposed Future Development Areas but do submit that an additional residential FDA should be created within records of title CB22F/884 and CB22F/885 if this area is not rezoned General Residential as is my preference.
