Sites & Areas of Significance to Māori

Wai Taoka Lines Submission

Tena Koe Paul Cooper

I would like to make a submission in relation to the positioning of the Wai Taoka Line along the boundary of our property at 312 Orari Back Road, Geraldine. The position of the Wai Toaka line determines the area for the Wai Taoka area overlay.

The Wai Taoka Line appears to have been positioned atop the stopbank along the eastern edge of our farming property.

The Stopbank was erected there for flood protection. The stopbank does not indicate the boundary of the waterway, only where the Timaru District council chose, due a number of different relevant factors, to place their flood protection. One factor would not have been where the areas of significance to Māori, in relation to the river margin, started or stopped.

As can be seen by the attached aerial photo the farming area includes an area on the eastern side of the stop bank. This is evident from the photo with the area not planted out for river protection and is bounded by a stock fence.

The Wai Taoka Line should be placed on boundary of the farming area, not arbitrarily where the stopbank was placed in more recent times for flood protection. As shown in the attached map this still leaves a significant margin area between the edge of the farming area and the waterway.

There are several examples along the Orari River, particularly to the North where the Wai Taoka Line has correctly been placed along the edge of the historical farming area, rather than arbitrarily atop the stopbank.

We respectfully ask that the Wai Taoka Line currently placed along the stopbank next to 312 Orari Back Road, Geraldine, be altered to be placed as shown on the attached map, on the boundary of the historical farming area. I believe this is a better representation of the start of the margin of the waterway.

I see the benefits of recording and protecting these sites and areas of significance, however the areas need to be correctly defined and recorded as part of this process.
