Notice of Hearing Timaru Proposed District Plan

Hearing E

Infrastructure; Subdivision; Cultural Values

Timaru District Council hereby gives notice in accordance with clause 8B, Schedule 1 of the Resource Management Act 1991 that the Hearing Panel appointed to consider submissions on the Timaru Proposed District Plan will hold Hearing E over five days commencing on Monday 10 February 2025 and concluding on Friday 14 February 2025 (or part thereof, subject to the number of submitters being heard). Hearings will commence at 9am each day and generally conclude at 5pm unless otherwise advised.

Hearing E will be held in the Council Chambers at Timaru District Council, 2 King George Place, Timaru.

In Hearing E the Hearing Panel will hear submissions on the following parts of the Timaru Proposed District Plan:

Further information regarding the procedure for Hearing E and the PDP Hearings generally, including Minutes issued by the Hearing Panel, is available at www.timaru.govt.nz/pdp and will be regularly updated as new information is available or new Minutes are issued.

The Hearings Administrator will contact all submitters that have previously expressed a wish to be heard with submission points allocated to Hearing E, 15 working days prior to the Hearing to confirm whether they wish to be heard and set individual hearing times, speaking time, and other matters. A submitter schedule detailing times each submitter will be heard will be made available at least 10 working days prior to the commencement of the hearing.

Pursuant to Minute 6, submitters intending to call expert evidence in support of their submissions are to provide written briefs of that evidence to the Council's Hearings Administrator at least 10 working days prior to scheduled hearing.

Deadlines for the pre-circulation of reports and evidence for Hearing E will be as follows (see Minute 6):
