Youth Initiatives Funding

The Council has set aside a fund to be used for community grants to support events, entertainment or activities which will contribute to the Timaru District being a vibrant and exciting place for youth.

1. Eligibility

Applicants can be community groups, individuals, school groups or social enterprises.

This fund supports activity-based projects catering to youth aged 12-25

All Council run funded or supported events are required to be promoted as "Smokefree/Vapefree".

Retrospective Applications: Applications will not be considered for expenditure incurred prior to the decision date.

2. Application Procedure

All applications are to be made on the Youth Initiatives Funding application form.

Application forms are available from the Timaru District Council offices in Timaru, Geraldine and Temuka and Council's website under Community Funding.

Annual accounts / bank statement and/or budget for the most recent financial year are to be supplied with applications.

When applying for \$2,000 or more, a copy of the resolution to apply to the Timaru District Council for funding is required.

Applications will be considered twice per year by the Youth Initiatives Subcommittee. The subcommittee is made up of three councillors, a representative from The YMCA, and two youth representatives.

3. Right Of Appeal

Every applicant has the right to appeal (in writing) a decision of the subcommittee, provided that the appeal contains new information not previously considered by the subcommittee.
