Submission:

- I support FDA10 the rezoning of the remainder of Pages Road from Rural 1 to Rural Lifestyle, and development plan Kellands Heights West
- I agree with the proposed lot sizes of 5000 m² (1.2 acres). At present a few lots along the north west side of Pages Road are approx. 5 acres (20,234 m²) in size, too small to be productive land, and too large for the average person/family to manage upkeep
- Timaru is lacking one acre sized lots. This is exactly what I was looking for 7 years ago when I purchased my property in Pages Road. Enough space to train my agility dogs, not be on the neighbour's doorstep, and not have to look after too much land. Unfortunately it was not possible to purchase a 1 acre block at the time. Lot sizes of 1 acre lots would give bigger families room to spread out, have pets and grow their own food. It would also provide sufficient space for people locating from some of NZ's bigger cities, to build bigger homes in a semi-rural setting. Development of Kellands Heights West is suited to provide 1 acre lots, in a location that makes sense with the current infrastructure (water, roading, footpath, kerbside rubbish collection) and proximity to schools and the town centre.
- I would like to see existing homeowners in the FDA Kellands Heights West, to have the ability subdivide prior to connection to sewer. Existing housing along rural 1, Pages road, already have septic/biocycles to manage waste. I propose that consents for new housing require connection to sewer. This will allow existing land owners to subdivide and sell lots sooner than 5 years. Lot buyers would be granted consent to build only with the provision of sewer, and existing lots could connect to sewer once the infrastructure is in place.
- With the upgrade to sewer, there should also be consideration for upgrades for storm water and telecommunications.
- I would be very willing to speak to council about the proposed rural lifestyle zoning and infrastructure, and have them visit my property in Pages Road

Relief sought

- I would like the Timaru District Council to push forward with rezoning Pages Road from rural 1 to rural lifestyle with allotment sizes of 5000 m² within 2 years
- I would like the Timaru District Council to allow subdivision in the rural lifestyle zone to begin for existing landowners without connection to sewer
